
THE FINAL LAP










The facilities with the largest number of deaths were Derby Lane and Daytona Beach Kennel Club with twelve each. Sanford Orlando Kennel Club followed with eight reported deaths. As of December 31, 2013 there have been no greyhound deaths reported at Mardi Gras Race Track or Melbourne Greyhound Park. Since the rule came into effect, Mardi Gras has only raced for one month (December 2013) and Melbourne finished its racing season in June 2013, weeks after the rule became effective.


According to state records, thirty-one greyhounds died or were euthanized for race related reasons.6 These reasons included dogs who were euthanized due to injuries suffered while racing, dogs that collapsed and died right after finishing a race, and a dog that suffered from suspected heat stroke after completing a race.7 An additional seventeen deaths appeared to be race related. Although the state notices did not contain definitive information on the dogs' cause of deaths, all seventeen dogs raced on or around the day they died and the race result comments indicated that the dogs suffered some sort of trouble during that race. For example, some comments note that the dogs "fell", "collided", were "hit" and/or" DNF" [did not finish].8

Cause of Death



A total of seventeen greyhounds died or were euthanized for reasons not related to racing, including illnesses, injuries incurred during turn out and in the sprint path, or dogs that were found dead in their kennels.⁹ In nine cases, the notifications did not provide any information on the manner or cause of death and there was no record of the dogs racing on the day of their deaths.

Deaths by Facility






Penrose Jake

A three-year-old fawn greyhound named Penrose Jake died after racing at Orange Park Kennel Club on August 22, 2013.¹⁰ According to his death notification, Penrose Jake died "after [the] 8th race".¹¹ The official notes from the track and the race replay indicates that he had collided with another dog.¹²

An Orange Park Tipsheet from one month before his death stated that Penrose Jake was "running hot" and a good dog for gamblers to bet on.¹³

(This chart does not include May 2013. The reporting requirement came into effect on May 21, 2013 and there was only one reported death in the remainder of May).


The month with the highest number of deaths was August, when fifteen deaths were reported.¹⁸ The full month with the fewest deaths was December (seven deaths).¹⁹ The average number of greyhounds that died per month was 10.4. This excludes May, since reporting was not mandated for the full month.

The gender of the greyhounds that died in Florida during the report time frame was fairly evenly distributed. Thirty-nine of the dogs were males (53%), thirty-four were female (46%) and the gender for one greyhound was not provided.²⁰


"the greyhound was just a puppy and could not be caught at the end of an official schooling race and died from extreme exhaustion."²¹ The most common age for greyhounds at the time of their death was between twenty-four and thirty-five months old (thirty-one, or 42% of dogs).²² The next most frequent age was between twelve and twenty-three months old (twenty, or 27% of dogs).²³

The two youngest greyhounds to die were only seventeen months old at the time of their deaths. **Tmc's Cates Cure** died at the Florida Kennel Compound on November 8, 2013.²⁴ During a training race she fell and broke her leg in several places.²⁵ **Tmc's Cates Cure** had not run in any official races before her death.²⁶

The other seventeen-month old greyhound that died had not even been given a name yet at the time of his or her death. The unnamed puppy fell into the rail while racing on the compound training track at the Flagler dog track.²⁷

AMF Preclude

On the evening of June 17, 2013 a two-year-old greyhound named AMF Preclude died after racing at Orange Park Kennel Club. According to official notes from the track, AMF Preclude fell and did not finish the race.²⁹

Just four days before her death AMF Preclude was listed on the official tip sheet for Orange Park as a good dog to bet on.³⁰ According to the sheet, she was a good pick because she was "running hot now" and a "good overall selection."³¹

Tempo Man Eater

Tempo Man Eater raced for the last time at Pensacola Greyhound Track on August 30, 2013. The following morning she refused to eat. Her trainer started to force feed her and contacted the kennel owner about the dog's condition.³²

The owner, who was out of town, told the trainer that he would take Tempo Man Eater to the veterinarian when he returned three days later.³³ The dog received no veterinary care, and was force fed until September 4, when she was found dead inside her cage.³⁴

Tempo Man Eater's body was brought to a local veterinarian, who told state officials that "nothing appeared suspicious" in the dog's death. No further action was taken.³⁵

When Tempo Man Eater died, she was two months shy of her second birthday and had only raced eight times.³⁶

Investigative Activity:

On September 4, 2013, at PENSACOLA GREYHOUND RACING, LLP, sometime between morning turnout and noon turnout, "TEMPO MANEATER", a greyhound with a left ear tattoo #57448 and right ear #111I, owned by Reginald Watson PMW license #8116909 was found deceased in its crate inside Kennel #6. The death notification was prepared on a form provided by PENSACOLA GREYHOUND RACING, LLP. (Exhibit 1)

Investigator TONY McDOWELL, conducted an interview on September 19, 2013 with James BAILEY PMW license #930419 in an attempt to determine the cause of death. Mr. BAILEY explained that the greyhound last raced on the evening of August 30 and on the morning of August 31, 2013 during feeding the greyhound would not eat. Mr. BAILEY stated that he force-fed the greyhound a small amount of food that morning and later that evening the greyhound relieved itself in the crate. Mr. BAILEY continued to force feed small amounts of food on Sunday and contacted the kennel owner Mr. Watson to advise him about the greyhound's condition. Because Mr. Watson was out of town, Mr. BAILEY explained that Mr. Watson advised he would take the greyhound to the veterinarian's office upon his return on Wednesday September 4, 2013.

According to Mr. **BAILEY**, from September 1 through the morning turnout period on September 4, 2013, the greyhound was force-fed. According to Mr. **BAILEY**, Mr. Watson at the time of noon turnout found the greyhound was deceased inside its crate. Mr. Watson transported the greyhound to Hillman Veterinarian Clinic in Pensacola, Florida for disposal.

On September 20, 2013, Investigator MCDOWELL contacted Hillman Veterinarian Clinic and verified they received the greyhound from Mr. Watson. Asked if anything regarding the condition of the greyhound appeared to be suspicious, the veterinarian stated that nothing appeared suspicious in the death of this greyhound.

Case Status: Final

Other Issues

On September 3, 2013 at 5:45 in the morning, a two-year-old brindle female greyhound named **Hallo Spice Kay** died at the Jacksonville Kennel Club compound.³⁸ The state investigation into Kay's death concluded "it appear[ed] the death could have been prevented had the greyhound

not been sprinted in the dark by Charles L. Browning helper for the James O'Donnell kennel."39

The greyhound death notices also indicate several instances when dog deaths were not reported within the mandated eighteen hour time period. For example, two greyhounds from the same kennel at Ebro Greyhound Park were euthanized after breaking their legs during races on September 7 and September 13, respectively.⁴⁰ However, the death notices were not faxed to the state until September 17, 2013.⁴¹
