

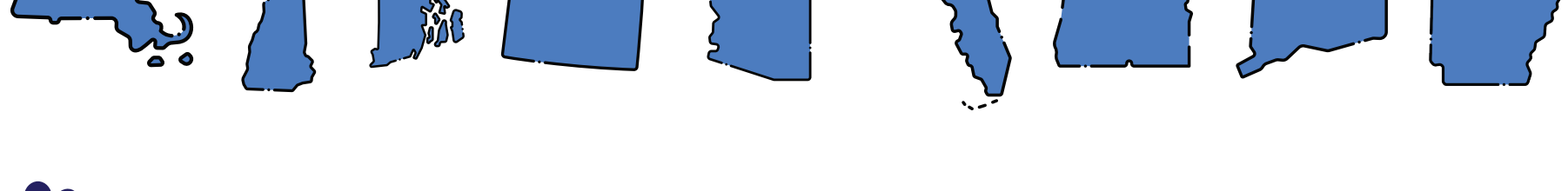


# GREYHOUNDS BENEFIT FROM LEGISLATIVE PRESSURE

Since our formation in 2001...

## WE HAVE PASSED TWENTY-SIX MAJOR GREYHOUND PROTECTION LAWS

including dog track prohibitions in nine states.



- Greyhound racing is **now illegal in 44 states**
- Forty-six dog tracks have closed or ended live racing
- There are two tracks remaining, in just one state



This is the start of GREY2K USA Worldwide

2001

Passed a requirement in **Massachusetts** that all greyhound injuries be reported to the public. The measure also mandated reporting on the final disposition of all racing dogs.

First and only state-funded greyhound adoption trust fund nationwide approved in **Massachusetts**.

2004

Championed the first greyhound injury and disposition reporting law in **New Hampshire**.

2006

Repealed a longstanding \$325,000 annual subsidy for dog racing in **New Hampshire**.

2007

Repealed an annual subsidy for the drug testing of racing greyhounds in **New Hampshire**.

2008



Passed a statewide ballot question to prohibit greyhound racing in **Massachusetts**.

Eliminated an exemption for racing greyhounds that existed under **New Hampshire's** state anti-cruelty laws.

2009

Passed a greyhound decoupling law in **New Hampshire**.

2010



Greyhound racing prohibited in **Rhode Island**.

Outlawed greyhound racing in **New Hampshire**.

2012

Passed a greyhound decoupling law in **Arizona**.

2014

Outlawed dog racing in **Colorado**.

Passed a greyhound decoupling law in **Iowa**.

Passed a greyhound injury reporting law in **Arizona**.

2016



Greyhound racing outlawed in **Arizona**.

Passed a greyhound protection ordinance in **Seminole County, Florida**.

Passed a greyhound injury reporting requirement in **Florida**.

2018



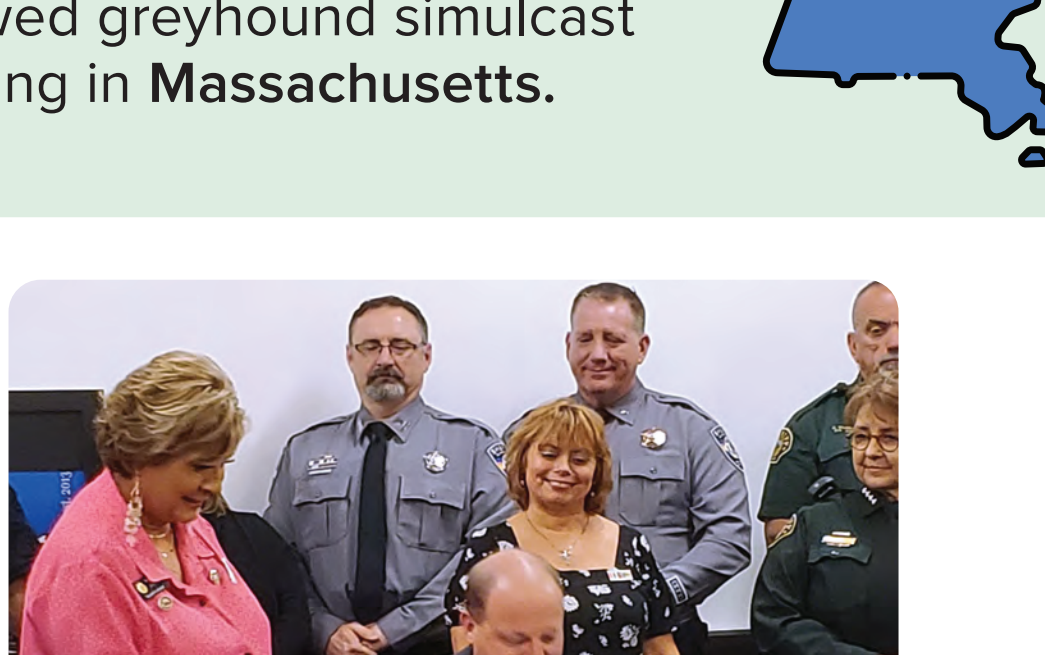
Championed a constitutional amendment that phased out dog racing in **Florida**.

2022

Passed a law to prohibit greyhound racing and also restrict remote gambling on dog racing in **Oregon**.

Outlawed greyhound simulcast gambling in **Massachusetts**.

2023



Passed a law to outlaw greyhound simulcast gambling in **Colorado**.

2024

Outlawed greyhound racing in **Connecticut**.

Passed a law to outlaw greyhound simulcast gambling in **Arizona** and **New Hampshire**.

2025

Outlawed greyhound racing in **Arkansas**.

Passed a bill to outlaw greyhound simulcasting in **Oregon**, and stop the processing of internet bets from across the country via the **Oregon** hub.

Gambling on dog racing has declined by nearly 80%
